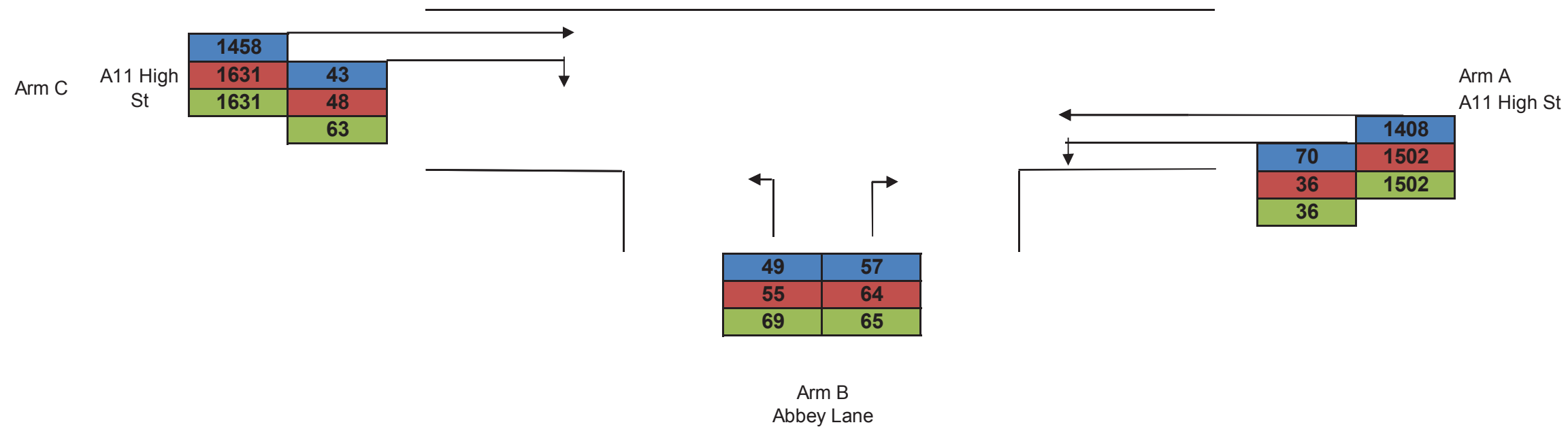

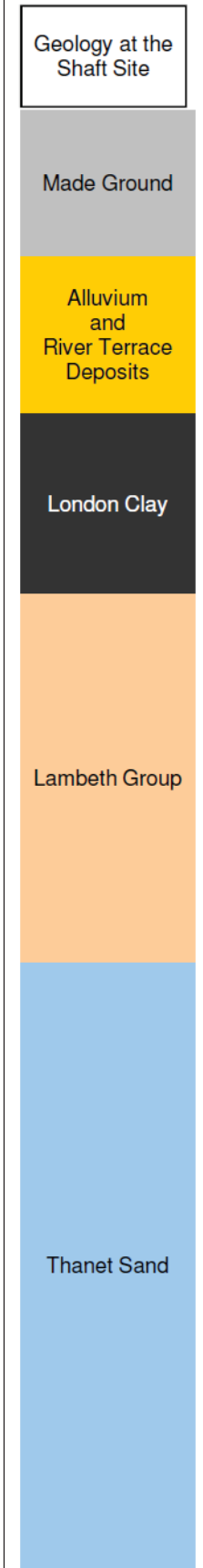
Upper aquifer monitoring locations



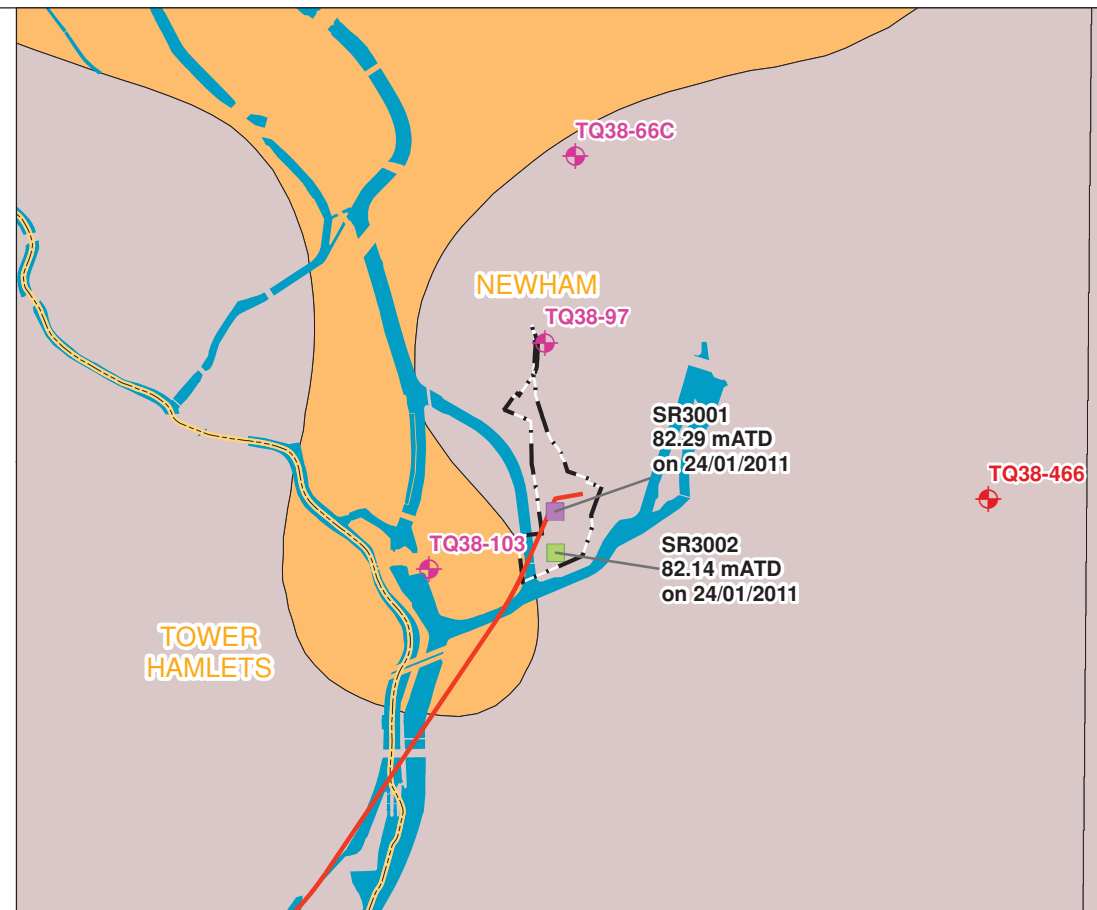
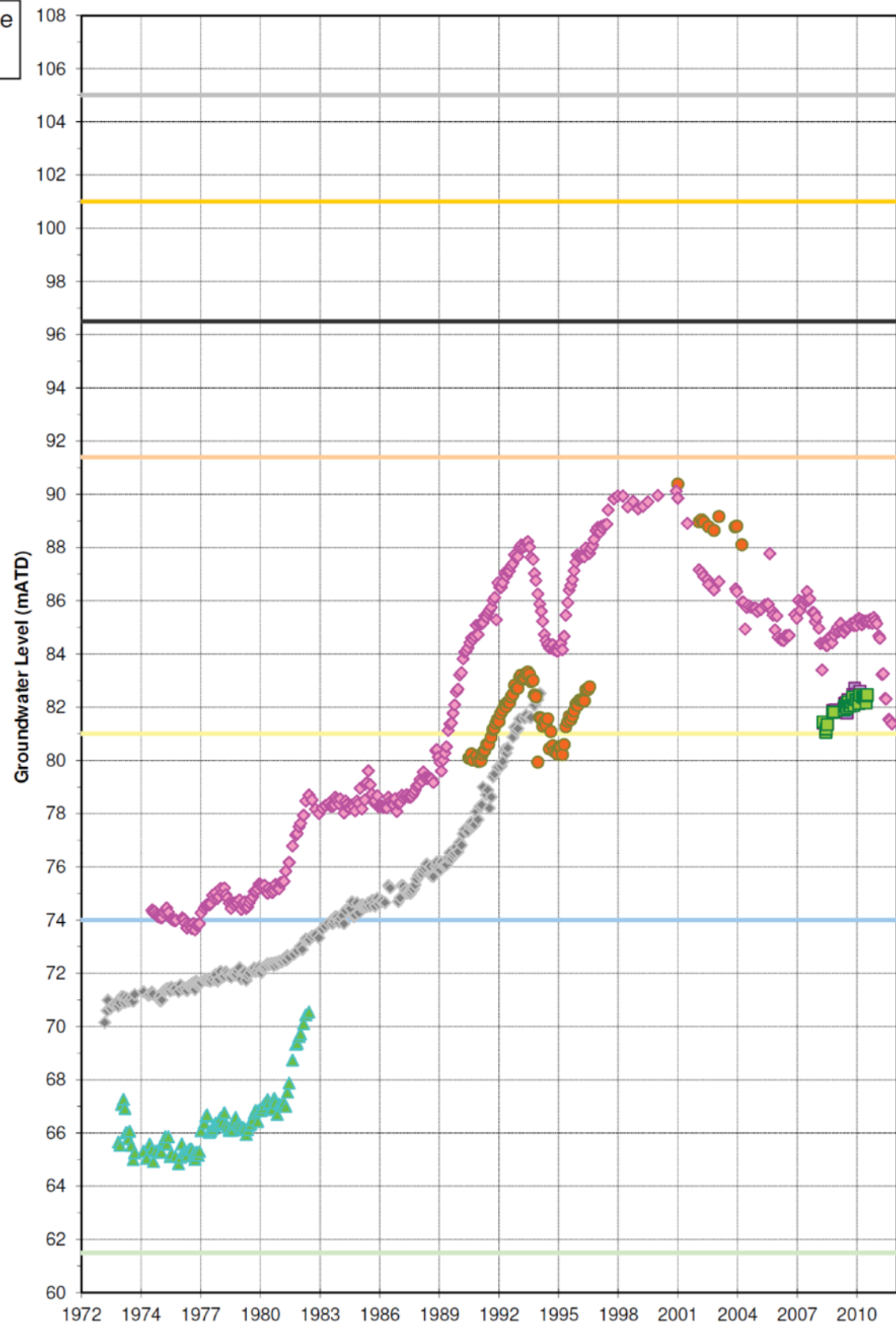
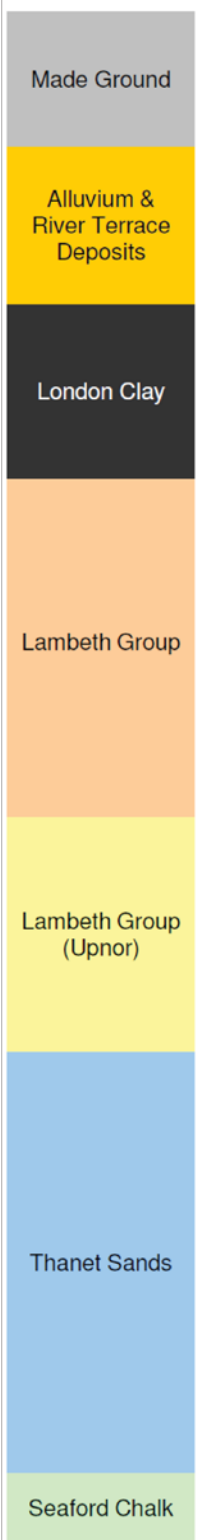

Geology at the Shaft Site

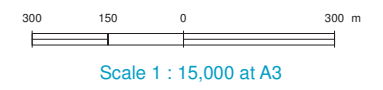
