10	<i>Urgent Compensation Case</i> The Panel received an email from the Project concerning whether a claim for compensation for loss of rent would be admissible (ref. 2350-TDWAY-TTTUN-990-ZZ-ZZ-717806).

Decision:	The claim would be admissible if it fulfils the requirements of section 8.2 of the <i>Non-Statutory Off-site mitigation and compensation policy</i> . Any claim would then be treated on its merits to establish what, if any, loss has been suffered as result of the scheme. The Panel notes that the Claimant has acquired the property in the full knowledge of the scheme.
