3	The Panel received a claim for compensation and noise-cancelling headphones (ref. 2350-TDWAY-TTTUN-990-ZZ-ZZ-720015).

Decision:	The Panel does not award cash compensation but will award various forms of mitigation from adverse impacts of the project. In order to consider a claim for mitigation, the Panel requires information from Tideway and further information from the claimant before we can determine the claim.

Decision:	The Panel answered the queries.

5	The Panel received a request to extend the ICP's temporary rehousing award (ref. 2350-TDWAY-TTTUN-990-ZZ-ZZ-720011).

Decision:	The Panel awards the continuation of temporary rehousing until the shaft within the acoustic shed has been excavated to its design depth as we are not in possession of any predicted noise data for activities following shaft excavation.

Item	Notes for the record
6	The Panel received a request to extend the ICP's respite award (ref. 2350-TDWAY-TTTUN-990-ZZ-ZZ-720014).

Decision:	<p>The Panel understands that the claimant has not agreed to the installation of the secondary glazing part of the TAP noise mitigation package; therefore the claimant has not taken reasonable steps to mitigate against the noise. However, the claimant can still request that the secondary glazing is installed now or at any time in the future during the Tideway construction works.</p> <p>Accordingly, the claim to extend the respite previously granted by the ICP is <u>not approved</u>.</p>

7	The Panel reviewed an award of respite during school holidays (ref. 2350-TDWAY-TTTUN-990-ZZ-ZZ-720018) which was originally awarded until the completion of the acoustic shed at Chambers Wharf.

Decision:	<p>The Panel awards 2 days respite holiday to be taken during the 2019 school spring half term (subject to the provision of receipts and in accordance with Tideway's conditions).</p> <p>At this stage, we can only award respite until the shaft within the acoustic shed has been excavated to its design depth (which is due for completion before the 2019 Easter school holidays) as we are not in possession of any predicted noise data for activities following shaft excavation.</p>

8	The Panel reviewed an award of rehousing (ref. 2350-TDWAY-TTTUN-990-ZZ-ZZ-720018) which was originally awarded until the completion of the acoustic shed at Chambers Wharf.

Decision:	The Panel has carried out an in-depth review of air quality monitoring information and is <u>not extending the respite</u> .
