Based on the information provided to the ICP, the ICP accept that Tideway has made reasonable endeavours to determine the practicability of installing Titon Sonair mechanical ventilators and balcony screens. Where secondary glazing is installed an alternative means of air circulation is to be provided.</p> <p><u>The TAP for Leeward Court (ref. 2000-TDWAY-EARPS-990-ZZ-OL-100000) is Approved on this basis.</u></p>
