

## **Monthly Report of the Independent Compensation Panel Chair**

### **July 2016**

The Independent Compensation Panel (the 'Panel') met on five occasions in July 2016.

#### **7 July**

##### *Purpose*

The Panel considered a Trigger Action Plan for Tideway Dock.

##### *Panel Members*

I was joined by a Building Surveyor and a Noise & Vibration Specialist.

##### *Decisions of the Panel*

The Trigger Action Plan was not approved owing to the typographical errors and points of clarification required.

#### **12 July**

##### *Purpose*

To consider a medical case ref. 2350-TDWAY-TTTUN-990-ZZ-OM-100067.

##### *Panel Members*

I was joined by a Medical Specialist, a Chartered Surveyor and a Noise & Vibration Specialist.

##### *Decisions of the Panel*

The Panel was of the view that it had insufficient information to make a determination. Air quality and noise impact information was requested, ready for the Panel to reconvene on 25 July 2016.

The Panel determined the level of compensation payable should the medical case be accepted on 25 July 2016

#### **18 July**

##### *Purpose*

The Panel considered a Trigger Action Plan for Tideway Dock.

##### *Panel Members*

I was joined by a Building Surveyor and a Noise & Vibration Specialist.

##### *Decisions of the Panel*

The Trigger Action Plan was approved

#### **25 July**

##### *Purpose*

To consider two medical special cases. Two different Panels sat to consider the cases they had been involved in previously.

### *Panel Members*

In both cases, I was joined by a Medical Specialist, a Chartered Surveyor and a Noise & Vibration Specialist.

### *Decisions of the Panel*

#### Medical special case 1

The Panel discussed medical case ref. 2350-TDWAY-TTTUN-990-ZZ-OM-100067 which had come before it on 12<sup>th</sup> July 2016 (ICP#30) following receipt from the Project of air quality and noise information from the Thames Tideway Tunnel Environmental Statement.

The Panel determined that there was a medical case for the Claimant to move to a property not directly affected by the Project within the local area and to compensate for the cost of the local move.

#### Medical special case 2

The Panel discussed medical case ref. 2350-TDWAY-CHAWF-990-ZZ-PF-100000 which had come before it on 27<sup>th</sup> June 2016 (ICP#26) following receipt of more information from both the Claimant and the Project.

The Panel determined that there was no medical case to support Tideway rehousing the Claimant.

### ***Other Work***

1. A Chartered Surveyor and I met with Flo on 1<sup>st</sup> July 2016 to comment on their proposed Trigger Action Plans and submissions to the Panel.
2. Two Chartered Surveyors and I met with Flo on 25<sup>th</sup> July 2016 for a trial run to fine tune the Trigger Action Plans and ICP Decision Sheet for a variety of houseboat interests.
3. I presented my Annual Report to the Tideway Reporting Group on 12<sup>th</sup> July 2016.
