<b>Decision</b>	<b>The requested financial award is NOT AWARDED.</b> The purpose of the non-statutory scheme is to provide mitigation where people are seriously adversely affected by the impact of the Tideway works. The Panel regrets that the contribution requested by this resident would not provide such mitigation so is not within the scope of the non-statutory policy. It is therefore not within the remit of the ICP to make the award as requested.
