Applicant reference	The Panel reviewed information pack Ref: 2350-TDWAY-TTTUN-990-ZZ-ZZ-720608 in support of an application for base plug pour mitigation (temporary respite).
Relevant Tideway site	Chambers Wharf
Decision	The requested mitigation was AWARDED

Item 2	Notes for the record
Applicant reference	The Panel reviewed information pack Ref: 2350-TDWAY-TTTUN-990-ZZ-ZZ-720607 in support of an application for compensation for the base plug pour.
Relevant Tideway site	Chambers Wharf
Decision	The requested mitigation was NOT awarded. The Panel is only able to award mitigation in the form of respite accommodation, it is not able to award compensation. the property is beyond the entrance to the Tideway site on Chambers Street and therefore no traffic will be passing the property the Panel believes that there is very limited possible impact from noise or air quality arising from the base plug pour traffic. A special case was not demonstrated by this family.

Applicant reference	The Panel reviewed information pack Ref: 2350-TDWAY-TTTUN-990-ZZ-ZZ-720608 in support of an application for base plug pour mitigation (temporary respite) and for air purifiers.
Relevant Tideway site	Chambers Wharf
Decision	The requested base plug pour mitigation was AWARDED. Air purifiers are NOT awarded The air quality around the site remains significantly better (less than half) the Air Quality Objective levels (the National Air Quality Objectives set out in the UK Air Quality Strategy) and accordingly the panel do not believe that dust or particulates arising from the base plug pour could ,materially compromise the family members health and therefore air purifiers are NOT awarded.
Item 4	Notes for the record
Applicant reference	The Panel reviewed information pack Ref: 2350-TDWAY-TTTUN-990-ZZ-ZZ-720609 in support of an application for extension to a previous award of temporary respite for a shift worker.
Relevant Tideway site	Greenwich
Decision	The extension to the requested mitigation was AWARDED for a period of 3 months from the date of this meeting, during which period the Panel will review noise data from the site to confirm if actual noise levels are as anticipated by the s61 notice and will also assess the impact of the operation of the vehicle holding area.

Item 5	Notes for the record
Applicant reference	The Panel reviewed information pack Ref: 2350-TDWAY-TTTUN-990-ZZ-ZZ-720 624.. The applicant requested an explanation for the Panel's decision not to award base plug pour mitigation.
Relevant Tideway site	Chambers Wharf
Decision	The requested explanation was provided. The Panel received an email from the claimant dated 13 June 2019 asking for an explanation of why an award was not made to her for respite during the base plug pour. The applicant resides on an upper floor of Hartley House and is located towards the middle of the rear façade of the building and does not have any windows facing directly towards the vehicle route. No special medical case was demonstrated by this applicant. Special medical cases have been demonstrated by other applicants which has led to awards being made to people who the applicant may consider to be neighbours. However, no

	<p>awards have been made at this time for base plug pour mitigation to applicants whose property faces only to the rear of Hartley House.</p> <p>In reviewing the base plug pour applications, the Panel also reviewed a large quantity of information relating to noise data and air quality data collected through monitoring of the activities around the Chambers Wharf Site.</p> <p>The Panel can assure the applicant that every effort has been made by the ICP to ensure that all applications are fairly considered and awarded on the basis of objective criteria. If the applicant is not satisfied that the Panel has followed due process she may appeal to the Independent Complaints Commissioner</p>

Applicant reference	The Panel reviewed information pack Ref: 2350-TDWAY-TTTUN-990-ZZ-ZZ-720625 in respect of an application for continuation of existing temporary respite accommodation beyond the expiry of the current tenancy in response to the installation of the vehicle holding area on Norman Road.
Relevant Tideway site	Greenwich
Decision	A decision on the requested mitigation was POSTPONED . The Panel requires further information from Tideway about the operation and duration of the vehicle holding area. The Panel would like to be updated on current noise levels from the site and predicted traffic levels for Norman Road with the vehicle holding area in operation. The Panel would also like clarification about whether vehicles will be instructed to turn off their engines and restart whilst using the vehicle holding area. For reconsideration by the Panel on 23 July 2019 or as soon as possible thereafter.
