Decision	The decision related to requested mitigation was UNCHANGED. The Panel undertook a site visit and note the proximity of the site entrance to of this flat. However, the Panel note that windows do not open onto Chambers Street and windows opening onto the balcony have a double set of windows. The Panel were able to witness construction vehicles turning into the site during the visit from outside the claimant’s property at ground level (where the impact would be greater) and together with its review of noise data identify noise levels which would ordinarily cause disturbance or impact upon the normal use of your property either internally or externally from vehicles involved in the base plug pour.
