The Panel referred to the architects plans of the building and notes that this property is to the rear of the building. The Panel has also undertaken several site visits to the Chamber's Wharf area, the most recent on Tuesday 9th July.

Decision	The Panel referred to the architects plans of the building and noted that this property is to the rear of the building, on the south-western corner. The Panel has undertaken several site visits to the Chamber's Wharf area, the most recent on Tuesday 9th July.



At a recent site visit the Panel clarified that the property is largely shielded from any noise arising from traffic on Chambers Street.
The property does not face the vehicle route and only has an oblique view of the proposed vehicle route from windows which are non-opening.
The Panel therefore considered that there is a very limited possibility of any impact of noise or dust intrusion arising from base plug pour traffic given the location of the property and the shielding effect of the building.

In the absence of any special circumstances and taking into account a recent general site visit, the Panel do not believe there is any significant risk of impact from noise or dust at this property arising from the base plug pour.

The Panel notes (from previous inspection of the building) that the flat has air conditioning and therefore windows should not need to be opened during the pour. Under circumstances where windows can be kept closed (as additional ventilation is not required for thermal comfort as air conditioning is available) internal noise levels relating to the base plug pour should be sufficiently mitigated to levels which would not ordinarily cause disturbance or impact upon the normal use of the property, including studying.
