<b>Site visit</b>	The Panel undertook a further site visit to the Kirtling Street operations, specifically to review the impact of the operation of the muck pile now that different ground conditions had been incurred whilst tunnelling. However, the conveyor was not operational at the time of the visit and no further information was obtained in addition to that obtained at the previous (recent) site visit.

<b>Applicant Reference</b>	The Panel reviewed information pack 2350-TDWAY-TTTUN-990-ZZ-ZZ-720936 in respect of an application for reinstatement of daily respite and holiday respite previously awarded until the shaft had reached design depth.

<b>Decision</b>	<b>The current award of mitigation is varied at the request of the applicant to allow the remaining 6 weeks holiday to be taken flexibly in blocks of not less than two weeks (maximum 3 blocks). No further award of mitigation is made.</b>
<b>Further information required/actions arising</b>	Claimant to contact Tideway if he would like to apply for black out blinds/curtains to be fitted to windows in habitable rooms facing the Tideway site.

<b>Applicant Reference</b>	The Panel reviewed information pack 2350-TDWAY-TTTUN-990-ZZ-ZZ-720941 and undertook a 12 month review of the previous award for daily respite.
<b>Relevant Tideway site</b>	King Edward Memorial Park
<b>Decision</b>	The daily respite mitigation was NOT extended following its expiry in August 2019. The Panel considered the works which were taking place when the original award was granted, which related to cofferdam construction (including piling) some 200m from the claimant's property. The ongoing works on the Tideway site do not include piling and are situated further away from the claimant's property.
