Details of the award	<p>The Panel had received email correspondence which indicated that the claimant had undergone training to become a volunteer vaccinator to assist with the national COVID-19 vaccination programme. The claimant has made a case for rehousing to assist him to get undisturbed sleep to allow him to carry out his volunteer role as a vaccinator. Whilst the claimant has put himself in this situation, the Panel recognises the special contribution he will be making to the community in respect of the pandemic and therefore consider him to be a special case as a night worker.</p> <p>The Panel has determined that the claimant should be awarded access on an as required basis to a serviced apartment or a hotel room until the end of February 2021. Decision	PART AWARDED
Details of the award	<p>The claimant has indicated that noise from the site has increased in recent weeks and that working from home has become difficult to the extent that it is affecting their mental health and ability 'to get a good sleep'. A video was reviewed which appeared to provide some evidence that, when windows are open, there was noise from the site.</p> <p>This property was previously subject to a Trigger Action Plan (TAP) which would have provided an opportunity for secondary glazing to be installed. It would appear that an offer of secondary glazing may not have been taken up although that offer should be available to the present owner of the property.</p> <p>As a precautionary approach until the status of the TAP is confirmed by Tideway, the Panel makes an award of noise cancelling headphones to a maximum cost of £100/set for each adult resident working from home within the property and any children home schooling.</p> <p><u>All awards are subject to Tideway's Guidelines for Implementation of ICP decisions.</u></p> <p><u>https://www.tideway.london/media/4138/guidelines-for-implementation-of-icp-decisions_feb-2020.pdf</u></p>

Details of the award	<p>The Panel is aware that water main works have been taking place immediately adjacent to the claimant's property to an extent that the ability to work from home has been compromised in respect of the nature of work which the claimant carries out.</p> <p>In the absence of specific noise data, the Panel has adopted a precautionary approach and makes an award of the cost of relocating to a flat identified by the claimant or a serviced apartment until the end of February 2021 when the specific water main works are anticipated to have been completed.</p> <p><u>All awards are subject to Tideway's Guidelines for Implementation of ICP decisions.</u></p> <p><u>https://www.tideway.london/media/4138/guidelines-for-implementation-of-icp-decisions_feb-2020.pdf</u></p>
