







What a difference after 1 month & Mining 10 Tunnel Rings!

The slurry has larger material removed by a Trommel, before the remaining slurry has water 'pressed out' and the resulting 'cake' is stock piled for removal by barge





#### **SECTION 61 - OVERVIEW**

Section 61 phase five for tunnelling works – approved by LB Southwark for October 2019 to October 2020



#### **Permitted Site Working Hours**

#### **Standard Working Hours:**

08:00 to 18:00 (Monday to Friday) and 08:00 to 13:00 (Saturday)

#### **Extended Working Hours**

- 18:00 to 22:00 (Monday to Friday). 08:00 to 17:00 (Saturday)
- General works limited to tidally influenced marine movements, lighting (task specific) and gantry crane movements within shaft enclosure

#### **Continuous Working Hours (24/7)**

Tunnelling and tunnel related activities such as;

- Annulus infill
- Launch and reception adit construction
- STP operation
- Shaft set-up for tunnelling, TBM install and launch

#### **Mobilisation and demobilisation Hours** •

- 07:00 to 08:00 and 18:00 to 19:00 (Monday to Friday).
- 07:00 to 08:00 and 13:00 to 14:00 (Saturday)
- 22:00 to 22:30 (Extended working hours activities) (Mon to Fri). 17:00 to 17:30 (Extended working on Saturdays)

Section 61 phase five for tunnelling works – approved by LB Southwark covers: October 2019 to October 2020

#### Section 61/working time details for upcoming shaft internal and annulus works

#### 1) Shaft internal concreting works

• Delivery of concrete wagons to site between 18:00 – 22:00hrs on one evening to facilitate internal pit-bottom platform creation. [estimate of ~3 deliveries per hour].

#### 2) Annulus infill works

- Weekday delivery of concrete wagons between 18:00 20:00 [estimate of ~3 deliveries per hour].
- Weekday delivery of GGBS/ cement tankers on weekday evenings between 18:00 22:00 [estimate of ~2 deliveries per evening].
- Saturday delivery of concrete wagons between 13:00 18:00 [estimate of ~3 deliveries per hour].
- Saturday delivery of GGBS/ cement tankers between 18:00 22:00 [estimate of ~2 deliveries].
- Sunday delivery of GGBS/ cement and aggregate [estimate of 5 6 deliveries]
- Concrete wagons discharging within acoustic enclosure.
- All deliveries screened by existing acoustic buildings.

## **Approved S61 for tunnelling works – more detail**



This Section 61 agreement covers:

#### **Tunnelling**

- Tunnelling will be a continuous activity: 24 hours / 7 days a week, ongoing now
- The slurry treatment plant will also run continuously to support tunnelling activities
