
Main Tunnel Secondary Lining

- Preparing to complete the 1st concrete pour week commencing 5 April











Connection Tunnel










5000 tonne of London Clay

5000 tonne of Concrete










- Soil Loaded into a skip at the pit bottom to a muck bin inside the acoustic shed
- Soil Loaded on to the conveyor by excavator inside the acoustic shed
- The existing Conveyor covers will be installed on a new much smaller conveyor to allow the spoil to be stored in a corner of the existing muck bin


New site layout

Key dates

- Main tunnel milestone achieved September 2020
- Connection tunnel January 2021 to December 2021
- Secondary lining April 2021 to January 2023
- Shaft works February 2023 to September 2023
- Removal of the acoustic shed August 2023 to September 2023
- Surface civil works September 2023 to January 2024
- Landscaping works January 2024 to April 2024
- Site demobilisation January 2024 to August 2024
- BMB vacate site Autumn 2024
- System testing and commissioning continues until 2024, though minimal on-site activity




