Details of the award	<p>The Panel considered the letters from the Southwark Law Centre and variously engaged with the ICP compensation experts and Tideway.</p> <p>The Thames Tideway Exceptional Hardship scheme does not provide for the payment of anything other than the unaffected (by the project) market value of the property.</p> <p>The ICP operates under the <i>Non-Statutory Off-site mitigation and compensation policy</i> and it is absolutely clear that the Panel does not have the remit to consider this claim and therefore the Panel cannot determine an award for this claimant.</p> <p><u>All awards are subject to Tideway's Guidelines for Implementation of ICP decisions.</u></p> <p><u>https://www.tideway.london/media/4138/guidelines-for-implementation-of-icp-decisions_feb-2020.pdf</u></p>

Applicant Reference	The Panel considered an email from the claimant dated 7 September 2021.

Decision	AWARDED
Details of the award	<p>The Panel considered the claim for takeaway meals ordered in August 2021 for consumption at home. The respite payments were intended to be used to enable the family to get away from the site during August in particular prior to the completion of the cladding of the slurry pipe bridge.</p> <p>It is recognised that the claimant may have been confused as to how the award could be used, although they could and should have contacted Tideway to request clarification as to how the award could be utilised.</p> <p>The Panel has determined that, in order to assist this claimant, an award is made in respect of payment of the costs of the takeaway meals subject to the limits previously set out.
