Details of the award	<p>The Panel is aware of the personal and health circumstances of the claimant and her family. The Panel had previously reviewed a number of videos of site activities which were mostly inconclusive as to the extent of any disturbance. The ICP Chair and Medical Specialist carried out a home visit to the claimant's property on the 10th May 2022 and the claimant was able to explain to the Panel members the effects of site noise on her and her family.</p> <p>The Panel notes that site activities will be changing now that tunnelling has been completed, such that many of the 24/7 support activities will cease and noisy activities should mainly be confined to the daytime period.</p> <p>Recognising the proximity of the claimant's property to the site and the number of occasions on which she has confirmed that the family</p>

Details of the award	<p>The Panel is aware of the personal and health circumstances of the claimant and her family. The Panel had previously reviewed a number of videos of site activities which were mostly inconclusive as to the extent of any disturbance. The ICP Chair and Medical Specialist carried out a home visit to the claimant's property on the 10th May 2022 and whilst at the property, the Panel members were able to view a video of site activities which provided the Panel with a greater understanding of the type and character of noisy activities. Details of the award	<p>The Panel is aware of the personal and health circumstances of the claimant and her family. The ICP Chair and Medical Specialist carried out a home visit to the claimant’s property on the 10th May 2022. The claimant explained her present concern that site activities were resulting in cracks on the walls of the property which the Panel inspected. It was the Panel member’s consideration that the cosmetic cracks were unlikely to be a result of vibration damage.</p> <p>The Panel has determined that the concerns of the claimant sit outside of the remit available to the Panel and that the contractor should make contact with the claimant to carry out a condition survey of the property and that they should explain the mechanism for dealing with any potential damage to the property.</p> <p><u>All awards are subject to Tideway’s Guidelines for Implementation of ICP decisions.</u></p> <p><u>https://www.tideway.london/media/4138/guidelines-for-implementation-of-icp-decisions_feb-2020.pdf</u></p>
