<b>Decision</b>	<b>Part Awarded</b>
<b>Details of the award</b>	<p>The Panel is aware of the claimant's personal circumstances and has previously visited the property with respect to noisy activities in the muck bin area.</p> <p><b>The Panel makes an award of respite allowance until the end of June 2022.</b></p> <ul style="list-style-type: none"> <li><i>Post Meeting Note:</i> The claimant subsequently requested that the award should include activities during specific trial days, i.e. prior to the ICP Meeting and, whilst the Panel does not usually make retrospective awards except in very exceptional circumstances, the award was amended by the Chair to include the Trial method periods: 19 to 22 April, 25 to 29 April and 3 to 6 May. <b>Decision</b>	<b>Part Awarded</b>
<b>Details of the award</b>	<p>The Panel considered the personal circumstances of the claimants and the location of their property in relation to the muck bin area. The Panel did not consider that alternative accommodation was appropriate recognizing that the noisy works would only occur during normal daytime working hours.</p> <p><b>Consequently, the Panel made an award of access to alternative office space until the end of June 2022 for the claimant and his partner.</b></p> <p><b><u>Note that the cost of appropriate office space should be agreed with Tideway Mitigation team.</u></b></p> <p><b><u>All awards are subject to Tideway's Guidelines for Implementation of ICP decisions.</u></b></p>
