<b>Details of the award</b>	<p>The Panel is fully aware of the personal health circumstances of the claimant and the location of her home. The Panel notes that all tunnelling has now ceased as have many of the outside activities, such as those in the muck bin areas and the spoil being removed by barges.</p> <p><b>Nevertheless, the Panel has determined that, on a very precautionary basis, taking into account the claimant's health issues, it extends the existing award of one night's respite a week with a carer until the end of November 2022.</b></p> <p>Prior to November 2022, the Panel will review the site activities and carry out a visit to the site to understand the on-going level of activities.</p> <p><b><u>All awards are subject to Tideway's Guidelines for Implementation of ICP decisions.</u></b></p> <p><b><u><a href="https://www.tideway.london/media/4138/guidelines-for-implementation-of-icp-decisions_feb-2020.pdf">https://www.tideway.london/media/4138/guidelines-for-implementation-of-icp-decisions_feb-2020.pdf</a></u></b></p>

Decision	<b>PART AWARDED</b>
Details of the award	<p>The Panel is aware of the location of the claimant's property and notes that most recently there have been particularly noisy works taking place in the muck bin area; however, that work has now been completed.</p> <p>The Panel does not consider that, based on the information available to it and having made a number of recent visits to the general site area, noise is likely to be at such a level as to regularly result in disturbance to the claimant and their partner. The Panel recognises that there will of course be occasional events on site which may well be noticeable.</p> <p>With respect to dust from the site, the Panel notes that in the past most of the materials being moved around within the area would have been damp and the Panel would not anticipate that soiling dust migration would occur from the site up to the claimant's property.</p> <p><b>The Panel has determined that no further award is made in respect of respite for noise disturbance and, with respect to dust, no award is made for air purifiers or cleaning costs. The Panel does, however, make an award of £110 for a year towards electricity running costs for the air conditioning units which were previously awarded.</b></p> <p>If the claimant considers that noise from the present site activities is still resulting in regular disturbance to the use of their property, then the Panel would be willing to carry out a home visit to understand the nature and scale of the disturbance at the claimant's property.</p> <p><b><u>All awards are subject to Tideway's Guidelines for Implementation of ICP decisions.</u></b></p> <p><b><u><a href="https://www.tideway.london/media/4138/guidelines-for-implementation-of-icp-decisions_feb-2020.pdf">https://www.tideway.london/media/4138/guidelines-for-implementation-of-icp-decisions_feb-2020.pdf</a></u></b></p>
