Details of the award	<p>The Panel has reviewed the on-going construction activities as reported by the site team.</p> <p>Whilst the Panel has not had the opportunity to view any videos of the site activities which the claimant states are occurring at night and disturbing her, the description of the noise activities and when the claimant was awakened has been taken into account. In particular, the Panel notes the nature of the claimant's work and the need to get uninterrupted sleep.</p> <p>The Panel has determined to make an award of noise cancelling headphones and makes an offer of an award of QuietOn 3 ear buds, Bose Earbuds or similar to the maximum cost permitted in order to assist with reducing the potential for sleep disturbance.</p> <p><u>All awards are subject to Tideway's Guidelines for Implementation of ICP decisions.</u></p> <p><u>https://www.tideway.london/media/4138/guidelines-for-implementation-of-icp-decisions_feb-2020.pdf</u></p>

Details of the award	<p>The Panel is aware of the circumstances and health aspects of the family members.</p> <p>The noise report for the ICP meeting on the 26th of July 2021 was reviewed.</p> <p>None of the construction activities would appear to be particularly noisy and the property benefits from the substantial barrier effects provided by the site offices and hence noise levels from the site alone at this property should be relatively low, apart from when abnormal loads are delivered to the site outside of normal working hours.</p> <p>Taking into account the circumstances of the family, the Panel has determined on a precautionary basis to make an award of one day respite a week for the claimant and her children. Details of the award	<p>The Panel is aware of the circumstances and health aspects of the family. The Panel notes the proximity of the claimant's property to the site entrance.</p> <p>The noise report for the ICP meeting on the 26th of July 2021 was reviewed.</p> <p>None of these works would appear to be particularly noisy and claims from the area are generally low.</p> <p>Taking into account the circumstances of the family, the Panel has determined on a precautionary basis to make an award of</p>

	<p>one day respite a week for the claimant and her children. Applicant Reference	The Panel considered the information contained in emails between the claimant and Tideway between the 2 nd and the 9 th August 2022.

Decision	DEFERRED
Details of the award	<p>The claimants’ situation is well understood by the Panel and the ICP Noise and Medical Specialists visited the area and the claimants flat on the 26th of May 2022. A report was provided of that visit which is on record.</p> <p>At the ICP meeting on the 12th of July 2022, an award was made and it is the Panel’s view that the previous award should have assisted with ensuring that the claimant’s husband was not disturbed by noise from the site and that they were both able to work from home when required. Therefore, the Panel is not minded to alter the previous award unless compelling evidence is made available to change this decision.</p> <p>In this respect, the Panel requires from Tideway the most recent Noise Reports for the site, the raw noise monitoring data for the last two months and any updated activities.</p> <p>Additionally, the Chair of the Panel had also offered a home visit which would be particularly useful in finalising any decision on this claim before it comes back to the Panel.</p> <p><u>All awards are subject to Tideway’s Guidelines for Implementation of ICP decisions.</u></p> <p><u>https://www.tideway.london/media/4138/guidelines-for-implementation-of-icp-decisions_feb-2020.pdf</u></p>
