Details of the award	<p>The Panel is aware of the location of the claimants' property in relation to the site activities and have reviewed the information pack provided. Details of the award	<p>The Panel has further reviewed correspondence from the claimant and whilst the Panel would usually expect to see correspondence from the claimant's doctor the Panel is content to accept the information provided.</p> <p>The Panel recognises that the claimant has experienced psychological distress in relation to noise exposure from Tideway construction activities. The Panel is prepared to fund an initial assessment interview with the medical professional requested.
