Decision	AWARDED
Details of the award	<p>The Panel is aware of the location of the claimant's property in relation to on-going works at the Carnwath Road site. The Panel has reviewed a number of videos and photographs provided by the claimant which identify noise from the works presently being carried out in relation to the construction of the air treatment chamber (ATC). Additionally, the Chair of the Panel carried out a recent visit to the site area to determine the extent of noisy activities as they would impact on the claimant's property.</p> <p>The current s.61 consented application for the CARRR site covers works from 1st December 2022 to 31st November 2023.</p> <p>From the s.61, the works which would appear to be significantly affecting 50 Carnwath Road are those to construct the air treatment chamber (ATC) which commenced in January 2023; these are located between the acoustic shed and the site hoarding. All works are planned to be carried out on dayshift only within core working hours.</p> <p>The videos and photographs show both the breaking out and the piling which are both very close to the property. Other works such as the acoustic shed removal may also impact the claimant's property.</p> <p>The Panel has determined to make a respite award for five days a week until the end of May.</p>

Decision	DEFERRED
Details of the award	<p>The Panel is aware of the location of the claimant's property and has visited the site area on numerous occasions. The Panel understands that recent works related to re-instating Kirtling Street will have been noisy during breaking out of concrete; however, those works have been managed by the contractors so as to reduce the total exposure of the noisier activities related to those works.</p> <p>The s.61 for the works has been viewed and spans the period 23rd June 2022 to 31st May 2023 (approx.12-month period).</p> <p>The noise monitoring report for KRTST/NM/1 does show some recent exceedances of noise limits but these are daytime only.</p> <p>The Panel has determined to not extend the respite award at this present time; however, the Panel would like to arrange a home visit to the claimant's property at which time they would reconsider the need for an extension of the existing respite award.</p> <p><u>All awards are subject to Tideway's Guidelines for Implementation of ICP decisions.</u></p> <p>https://www.tideway.london/media/4138/guidelines-for-implementation-of-icp-decisions_feb-2020.pdf</p>
