Details of the award	<p>The claimant has various medical issues as described by the medical specialist.</p> <p>At ICP meeting # 237 on Tuesday 12 September 2023, a previous award was extended until the end of December 2023.</p> <p>The above award was for the claimant and her carer. The claimant is now requesting that the two days respite per week for herself and her carer is reinstated due to the disturbance caused by concrete breaking at the site.</p> <p>There is little current information available for activities on the CARRR site but, a Tideway e-mail of the 5th of December 2023 was taken into consideration.</p> <p>The Panel has given careful consideration to this claim in light of the claimant's medical issues and an award is made at the standard rate for the claimant and her carer to continue until the end of March 2024.</p> <p><u>All awards are subject to Tideway's Guidelines for Implementation of ICP decisions.</u></p> <p><u>https://www.tideway.london/media/4138/guidelines-for-implementation-of-icp-decisions_feb-2020.pdf</u></p>
