<b>Details of the award</b>	<p>The claimant contacted the ICP by e-mail dated 7th of May 2024 and has submitted five videos.</p> <p>These videos variously portray droning and concrete breaking which support her claim.</p> <p>The claimant is requesting:</p> <p>An extension to the current respite award of 2x days daytime respite until end of May 2024/end of the noisy works at the Tideway site.</p> <p>An e-mail from the Senior Community Relations Manager of the 8th of May 2024 to the claimant and an update of the 22nd of April regarding works at the main GREPS site have also been taken into consideration.</p> <p><b>The Panel has considered this claim very carefully in respect of the videos and the construction programme and has determined that the current respite award should be extended until the end of July 2024. <b>Details of the award</b>	<p>The Panel has determined that Tideway may implement this award without the need for a separate meeting of the ICP. The claimant has therefore been awarded respite for 2 adults and 2 children of school age as below:</p> <ol style="list-style-type: none"> <li>1. For each adult who is normally resident in the property: 2 days respite/ week at the standard rate of £30/day.</li> <li>2. For each child, over the age of one year, who does not attend school, 2 days respite/week at the standard rate.</li> <li>3. For each child who would normally attend school during the term time week: 1 day of respite per week to be taken at the weekend.</li> <li>4.
