I'd also very much like to apply for a pair of noise cancelling headphones to help reduce the overall impact. Additionally, it would be helpful to receive support for any weekend disruption.</i></p> <p>The following information has been taken into consideration:</p> <ul style="list-style-type: none"> - The current situation for the CHAWF site is that there is a dispensation in place for the period 1st January 2025 until completion of the works at the end of August 2025 assuming works run to programme. However, the high-level works programme indicates an end in September 2025 (see below). However, the recent CLWG meeting held on the 16th of June 2025, included an updated construction programme for the CHAWF site. Details of the award	<p>This claimant has supplied five videos taken from her balcony which variously show light construction plant moving materials on site together with passing DLR and overground trains. None of the videos are from inside the dwelling. Other industrial and commercial uses are also nearby. There have been multiple previous claims.</p> <p>She is claiming:</p> <p><i>Extension of the current award until the end of Sept 2025 or the known end of noisy works on the site.</i></p> <p>The S.61 for this site is dated 7th February 2023 and runs to the end of works. The predicted noise levels are provided for 'Scenarios' although these are not specifically described although the various works are described in detail.</p> <p>From the programme at page 76 of the S.61, it would appear that all works should be complete at Phoenix Wharf by now but obviously that is not the case. Given how the scenarios work and the programme, and given there are no baseline ambient levels for the closest site, the S.61 is not helpful in determining effects. The two provided noise monitoring reports are too dated to be helpful for current activity and noise levels.</p> <p>There is a site update email from the PM dated 15th July 2025 which has also been taken into consideration.</p>

	<p>The Panel has considered this case very carefully and note that the construction related works are sporadic in nature and do not involve a great deal of site activity. The Panel has reviewed the videos provided. Accordingly, the Panel is of the view that there is little evidence to justify an extension of the award. However, the recent CLWG meeting held on the 16th of June 2025, included an updated construction programme for the CHAWF site. This report provides a summary of the revised programme and the implications for awards currently running but due to end at the end of July 2025. - The Engagement Manager for the site has provided an update to works by e-mail dated 9th of December 2024. - The programme for these works, updated from the Chambers Wharf–Community Liaison Working Group meeting - Tuesday 11 February 2025: - The current and upcoming site activities update of 18th of July 2025 for the week commencing 14th of July 2025: - Chambers Wharf Community Liaison Working Group June 2025.

	<p>The Panel notes that at ICP meeting # 287 following a review of all of the available data in respect of the CHAWF works, it determined to amend existing claims such that:</p> <p><i>The Panel has reviewed the revised programme and has noted that the pile removal is not continuous and often there are days when no piles are removed albeit with some activity within the cofferdam area removing material onto a barge. Additionally, the Panel recently visited the general area surrounding the Chambers Wharf site to observe the various construction related activities. Accordingly, the Panel has determined to amend the existing fast-track award and all other similar awards in the Chambers Wharf area.</i></p> <p><i>The amended award which will apply from the 1st of August 2025 until the 30th of September 2025 will be one day of respite a week for each qualifying person at the standard cost.</i></p> <p>Having reviewed all of the available information in respect of this claim, the Panel makes an award of one day of respite a week at the standard rate until the end of September 2025.</p> <p>Additionally, the Panel makes an award of the cost of 2 No. noise cancelling headphones to a maximum cost of £100.</p> <p>The Panel has visited the moorings and are of the view that there is very little dust coming from the site as the material which is being moved is pre-dominantly damp and therefore no award in respect of cleaning costs is made.</p> <p><u>All awards are subject to Tideway's Guidelines for Implementation of ICP decisions.</u></p> <p><u>https://www.tideway.london/media/4138/guidelines-for-implementation-of-icp-decisions-feb-2020.pdf</u></p>
