Normal working hours for other activities are:

- Monday to Friday: 8am 6pm

Concrete breaking activities will only take place:

- Monday to Friday: 8am 6pm
- Saturday: 9am 2pm (starting and finishing an hour later than standard hours)

We endeavour to finish all work onsite by 6pm, but other support activities, such as moving materials and pouring concrete, may continue until 8pm.

Tidally-affected activities, such as cofferdam removal, may take place from 5am to 10pm. This includes excavation, cell dismantling, stockpiling materials, lifting activities plus barge loading and movements. We try to plan our work so noisy activities do not start before 8am or continue after 6pm.

- 5. In addition to the above, a CHAWF remaining works programme has been issued which indicates that high noise activity could continue on and off, through to April 2026.
- 6. It should also be noted that the ICP makes regular visits to particularly active sites and CHAWF is one of those. A site visit to CHAWF was carried out on Thursday 20<sup>th</sup> of August 2025 at which time, vibratory pile removal from toe (partial) and complete pile removal by crane, were witnessed from the closest possible locations as representative of residents affected by the works. What was witnessed was the removal of intermediate piles, i.e. every other pile had already been removed. Due to the extra friction likely to be associated with initial pile removal from a complete row, noise levels from the vibratory removal tool are acknowledged as potentially higher.

The recommendations made by the ICP are therefore based upon a review of all the available information including personal on-site observations from site visits.

The Panel is aware of the ongoing works at the CHAWF site both in terms of written information and weekly reports but also from numerous site visits. Whilst elements of the current works are noisy, particularly during pile removal or any residual concrete breaking, high

An extension would provide us with a necessary break from the construction noise and significantly reduce the detrimental impact on our health and wellbeing.
	4. Request for Financial Compensation



	In addition to the mitigation request, I am seeking financial compensation for:
	Loss of the quiet enjoyment of my home.
	Additional costs incurred due to the disruption (alternative rest arrangements, potential accommodation costs, childcare adjustments, etc.).
	Emotional distress and negative impact on my health and family life.
	I ask that ICP/Tideway assess these damages fairly and provide appropriate compensation.
	Should my claim not be resolved satisfactorily, I reserve the right to seek independent legal advice and pursue all available legal remedies.
	The Panel is aware of the ongoing works at the CHAWF site both in terms of written information and weekly reports but also from numerous site visits. Whilst elements of the current works are noisy, particularly during pile removal or any residual concrete breaking, high levels of noise do not occur all the time and noise from the site is mostly much quieter.

	My children would benefit from being out of the area for a few days a week and away for their health and mental health also.
	A choice of paid activities so my kids are not constantly breathing in the polluted air from the site.
	The Panel is aware of the ongoing works at the CHAWF site both in terms of written information and weekly reports but also from numerous site visits. Whilst elements of the current works are noisy, particularly during pile removal or any residual concrete breaking, high levels of noise due not occur all the time and noise from the site is mostly much quieter.
	The Panel has taken into account the information provided by the claimant and the location of the property. Accordingly, the Panel has determined to award two days respite a week for all family members at the standard cost. The award extends until the 31 <sup>st</sup> of December 2025, or until the noisy works cease, whichever is the sooner.
	The Panel notes the comment about polluted air; however, monitoring of air quality in the vicinity of the site has not identified levels of particulates that are any higher than elsewhere in London.

Details of the	This clamant has now come back to the ICP requesting:			
award	In light of our medical and well-being circumstances, I am requesting that ICP:			
	1. Include overnight stays within the respite award, to allow my family periods away from the relentless noise and provide meaningful support for both medical care and mental health.			



2. Allow accumulation of daily respite within a week, so that unused portions can be pooled to fund larger respite activities. For example, if we spend £5 on one day and £15 on another, accumulation would allow us to use the full weekly entitlement (£240 for a family of four) for a single, impactful respite activity.
The impact of this construction is not minor or occasional. It is a persistent, intrusive, and debilitating problem that has affected our family for nearly a decade. Each extension of works compounds the stress, anxiety, and health

Whilst elements of the current works are noisy, particularly during pile removal or any residual concrete breaking, high levels of noise due not occur all the time and noise from the site is mostly much guieter.

risks. It is vital that ICP considers the long-term severity and ongoing nature

of this disturbance, rather than treating it as a short-term issue.

The Panel has taken into account the information provided by the claimant and the location of the property. Previously, the Panel determined to make an award of two days respite a week for all family members at the standard cost. That award extended until the 31st of December 2025, or until the noisy works cease, whichever is the sooner.

The Panel has considered very carefully the request to accumulate the weekly respite award and has determined that the weekly respite may be accumulated over monthly periods to pay for a single respite activity, noting that such activities should be agreed with Tideway Mitigation in advance. As before, the award is extended until the 31st of December 2025, or until the noisy works cease, whichever is the sooner.
